In exchange for being permitted to participate in these activities, for myself, my heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against the South Creek Foxhounds, or its Masters, Officers, Directors, Members, Employees, or Guests or and Land Owners, Landholders, or other persons making property available for the South Creek Foxhounds, for injury (including death), to me or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my participation in these dangerous horseback riding, foxhunting, or related activities; and I also agree if anyone makes any claims because of injury to me (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims.

A current negative Coggins test is required by law for every horse present at a public event. South Creek Foxhounds requires every riding member to make a copy of his or her current negative Coggins test to present to the Field Secretary upon arrival at the Hunt or South Creek Foxhounds riding event.
